Sub: Commission decision on the HEIs representation submitted for review of programmes found deficient, for recognition for academic session January, 2020 only, to be offered in Open and Distance Learning (ODL) mode- regarding.

Sir/Madam,

This is in continuation to the UGC letter of even number dated 03.09.2019, wherein the details of programmes found deficient along with deficiencies and other relevant information/conditions were communicated to **Graphic Era University, Uttarakhand.**

2. As per the provision at clause 4 (i) of sub-regulation (3) of Part- II of the University Grants Commission (Open and Distance Learning) Regulations, 2017 and the decision of the Commission in its 543rd meeting held on 9th August, 2019, for the programmes found deficient as per the UGC letter cited in above para, the Higher Educational Institution had been provided an opportunity to submit representation along with documentary evidence, if any, within 30 days from the date of the said UGC letter.

3. The representation along with documentary evidence submitted by the **Graphic Era University, Uttarakhand** on 23.08.2019 for review and the justifications given by the HEI representatives during the hearing, were considered by the duly constituted Expert Review Committee in the meeting held on 4th/ 5th/ 27th September, 2019 at UGC, 35 Feroze Shah Road, New Delhi - 110001. The Expert Review Committee based on the provisions of the University Grants Commission (Open and Distance Learning) Regulations, 2017 and its amendments; made recommendations for consideration of the Competent Authority.

4. Based on the decision of the Competent Authority, I am directed to issue this Order, thereby communicating the Commission decision, on the representation received, for programme wise recognition status of the programmes to be offered in Open and Distance Learning mode for **academic session January, 2020 only** by the **Graphic Era University, Uttarakhand** as detailed in point no. 5 below.

5. Programme wise recognition status based on representation:

5(A) Programmes Recognised*

The Commission has also directed that the HEIs shall upload the admission details within ten days from the last date of the admissions in the respective academic session i.e. 10th September for July academic session and 10th March for January academic session. Accordingly, the HEIs shall comply with the above decision of Commission.

11. The Commission in its 543rd meeting held on 9th August, 2019 had decided that -

In case of dual mode university, the upper limit of intake in Science based programmes in ODL mode should be three times conventional intake and in case of Open University, the numbers should be commensurate with the capacity of its Learner Support Centres to provide lab facilities to the admitted students.
